Note: The Company has completed the acquisitions of Shenhua Shendong Power Company Limited and Shenhua Group Shenfu Dongsheng Coal Company Limited in August 2007. The operational data of two companies between September and December of 2007 is included in the gross power generation and total power output dispatch data of the Company in 2007. The gross power generation and power output dispatch of the two companies between January and August of 2007 is 2.63 billion kwh and 2.32 billion kwh respectively, the gross power generation and power output dispatch of the two companies between September and December of 2007 is 1.40 billion kwh and 1.24 billion kwh respectively, and the gross power generation and power output dispatch of the two companies between January and December of 2006 is 2.50 billion kwh and 2.18 billion kwh respectively . The construction of Shenhua Tianjin Coal Dock was completed in October 2006 and the production period in 2006 is calculated based on two months.

The major operational data of December and the whole year of 2007 were calculated based on the internal statistics of the Company. As a result, major differences may exist between the monthly operational data. The factors giving rise to such differences include without limitation to bad weather, equipments overhaul, seasonal factors, and securities checkup and so on. The major operational data may somewhat differ from the data disclosed in the relative periodic reports. The investors are hereby reminded of the risks which may result from inappropriate reliance upon or utilization of the information given above.
