For the period from January to November 2016, the Company's coal sales volume increased by 6.8% year-on-year, which was primarily due to substantial increase in sales volume of coal purchased from third parties as a result of the utilization of the Company's own transportation capacity and favorable market opportunity with intensified efforts in coal source organization and coal sales; while the average selling price of coal of the Company was approximately RMB306/tonne (exclusive of tax), representing a year-on-year increase of 3.7%.

For the period from January to November 2016, the Company's total power output dispatch recorded a year-on-year increase of 4.7%, mainly attributable to the Company's intensifying marketing efforts and its efforts to increase power generation, as well as an increase in installed capacity of power generators.

The major operational data above were calculated based on the internal statistics of the Company. As a result, operational data may show major differences from month to month. The factors giving rise to such differences include, without limitation to, changes in weather, equipment overhaul, seasonal factors, and safety checkup and so on.
