In November 2021, the main reason for the year-on-year increase in the commercial coal production of the Company is that the Company scientifically organized coal production to increase production and supply; the main reason for the year-on-year decrease in the Company's coal sales volume is that part of the coal sales settlement was behind schedule.

In November 2021, the main reason for the year-on-year decrease in the Company's sales volume of polyethylene and polypropylene is that the outward transportation volume of the products was reduced due to freight transportation organization of railway.
