In December 2021, the main reason for the year-on-year increase of the Company's coal business operation indicators was that the Company scientifically organized coal production to realize the increase in production and supply.

In December 2021, the main reason for the year-on-year increase of the Company's transportation business operation indicators was that the Company strengthened coal transportation to ensure energy supply.

In December 2021, the main reasons for the year-on-year increase of the Company's power generation business operation indicators were that several new power generator sets of the Company had been put into operation since 2021 and the power demand of the whole society increased.

In December 2021, the year-on-year increase of the Company's coal chemical business operation indicators were mainly due to the decrease in the production of polyethylene and polypropylene in the same period of last year, as well as the Company's reduction of product sales due to changes in market consumption structure and price fluctuation, resulting in a lower base. The main reason for the year-on-year decrease in the operation indicators of coal chemical business in the whole year was that the coal-to-olefin equipment of Guoneng Baotou Coal Chemical Co., Ltd., owned by the Company was scheduled for maintenance from September 15 to October 21, 2021, resulting in a decrease in output.

The major operational data above were calculated based on the internal statistics of the Company. Operational data may show major differences from month to month. The factors giving rise to such differences include, among others, changes in weather, equipment overhaul, seasonal factors and safety inspection. The major operational data may somewhat differ from the data disclosed in the relative periodic reports.
