The board of directors and all its directors of the Company guarantee that the information set out in this announcement does not contain any false statements, misleading representations or material omissions, and take legal responsibility as to the truthfulness, accuracy and completeness of the content herein.

Recently, No. 4 power generation unit of the Phase II Expansion Project ("Beihai Phase II") of China Energy Guangtou Beihai Power Generation Co., Ltd. ("Beihai Power"), a controlling subsidiary, approximately 52% equity interest of which is held by China Shenhua Energy Company Limited (the "Company"), successfully passed the 168-hour trial operation and has been transferred to commercial operation. As a result, both two 1,000 MW ultra-supercritical single-reheat coal-fired power generation units of Beihai Phase II have been established and put into operation.
